

NationExpat.com - Privacy Policy

General

Your privacy means the world to us, we take it seriously so you can feel comfortable using our web site. Our Privacy Policy is restricted to the part of the website that we own, control and write ourselves. Some parts are collected elsewhere (e.g. datafeeds), or written by individuals that are not our employees, such as agents, service providers, etc.; for which this Privacy Policy does not apply.

For your comfort: member information collected at the time of registration may be used only for the administration of this site and its activities (such as our newsletter), but will not be sold or otherwise distributed to third parties without the member's prior written consent, except when required by law.

1. Data collection

Our website is free to visit by anyone around the world. For entering or editing data, users may need to login. The username and password are the only mandatory fields for registration. All extra data, which we kindly ask to enter, is optional. Please take note that your user name, e-mail address, or other submissions that you make on this site may contain your real name or other personally identifiable information and, as a result, may appear on this site if so designated in your account options.

Like many web sites, we may also automatically receive general information that is contained in our server log files such as your IP address, browser used, date, time and duration of access and cookie information. BeneluxExpat.com uses this information to monitor, preserve and enhance the functioning and integrity of the system. Information is collected for analysis and statistical purposes, and is used to help diagnose problems with the server and to carry out other administrative tasks, such as assessing what information is of most interest, determining technical design specifications and identifying system performance and/or problem areas. This information is not used in any way that would reveal personal information to external constituencies except as described above.

2. Cookies

BeneluxExpat.com tries not to set or use cookies, only when there is no option for full the functionality of the website we switch over to the use of cookies. If there is advertisement on our website that appears to use cookies, your cookies are still there from previous usage of other websites. Companies providing advertisements do not have access to our cookies. These companies usually use non-personal identifiable or anonymous codes to obtain information about your visits to our site.

3. Data usage

BeneluxExpat.com will take all reasonable actions to prevent the disclosure of your data to third parties unless (i) otherwise provided for in this Privacy Policy; (ii) we obtain your consent, such as when you choose to opt-in or opt-out to the sharing of data; (iii) a service provided on our site requires the interaction with or is provided by a third party; (iv) pursuant to legal process or law enforcement, we are required to disclose your data; (v) we find that your use of this site violates this Privacy Policy, Terms of Service, other usage guidelines or it is deemed reasonably necessary by us to disclose your data in order to protect our legal rights and/or property; or (vi) this site is purchased by a third party whereby that third party will be

4. Interactive Functions

For fora and blogs, BeneluxExpat.com does not routinely retain logs or copies of fora; however, information disclosed in these areas is public.

5. Editing or deleting personal and account information
